## **Stark County Bar Association Resumes Driving License Clinics**

The Stark County Bar Association has been part of the statewide effort to ensure that a larger percentage of drivers on our roads have a valid driving license and carry insurance.<sup>1</sup> In 2019, we started a VALID Clinic to help people whose licenses have been suspended navigate the path to regaining their driving privileges. The VALID Clinic model has been well established and operates successfully in many other Ohio counties. At the clinics, participants have their driving records printed out from the Ohio Bureau of Motor Vehicles (BMV) web site. Participants then met with volunteers to review and interpret their driving records. Volunteers explain the steps necessary for the person to regain his or her driving privileges depending on the type of suspension (court ordered, failure to pay child support, lack of

insurance when involved in an accident, etc.). Specific information is provided about where to go and what to expect at the Alliance, Akron, Barberton, Canton, Massillon, and Stow Municipal Courts. Locations and contact information for deputy registrars, approved remedial driving programs, and testing sites are also given out. In addition, participants are also counseled concerning the BMV Amnesty Program under which they may be eligible for a reduction in fees owed to the

## BMV.

Volunteers received free training at a CLE provided by the SCBA on Wednesday, October 19. Judge Todd McKenney of the Barberton Municipal Court, and Darlene Jones, from the Bureau of Motor vehicles provided the substantive training, and Dottie Callander, Denise Fishel, Magistrate Andrea Scassa, and



Sharon Ackerman, explained procedures in the Alliance, Canton, and Massillon Municipal Courts.



**Krugliak, Griffiths, Wilkins and Dougherty**, donated supplies for the clinic, contributed marketing efforts, and recruited many of their staff members to volunteer. In addition, the following organizations were extremely helpful in making the clinic a success by informing their clients and patients of the opportunity:
